# Representation Of Sexual Violence Of Minors In Mass Media: Case Study Liputan6.Com

#### **Abstract**

This article discusses the representation of sexual violence against minors in the mass media, a case study of Liputan 6.com. The aspects highlighted and the framing of news about sexual violence against minors which focuses on the case of 13 female students who were abused by their own teachers in online media merdeka6.com through media text analysis framing William A. Gamson model. The research results show that Online media Liputan6.com frames news about victims of sexual violence, tends to raise the incident of sexual violence against 13 female students as something that is of great interest to the public. This incident is very unfortunate because the Islamic boarding school teachers who should be educating, looking after and protecting their female students actually commit sexual violence so that Some people no longer trust their children to study at Islamic boarding schools.

#### Introduction

Children are an investment in the afterlife that should receive serious attention. (Sarifa Suhra, 2022: 1) However, in reality In Indonesia, cases of sexual violence increase every year. The victims are not just adults, now they have spread to teenagers, children and even young people. The phenomenon of sexual violence against children is increasingly occurring and has become global in almost all countries. Cases of sexual violence against children continue to increase from time to time. This increase is not only in terms of quantity or number of cases that occur, but also in terms of quality. What is even more tragic is that the perpetrators are mostly from the family or environment around the child, including in their own home, school, educational institutions and the child's social environment. (Ivo Noviana, 2015: 14)

One of the cases that attracted the attention of many parties was the alleged rape and molestation of two girls in Padang, West Sumatra in 2022, by seven perpetrators who were close relatives and neighbors. Padang Police Criminal Investigation Unit Head, Commissioner Rico Fernanda, said the police had arrested five people. The other two, namely the victim's neighbor and uncle, are still at large. "To date, we have arrested five perpetrators, namely the victim's grandfather DI (65), the victim's uncle AO (23), the victim's older brother RM (11), GA (9) and AD (16)," said Police Commissioner Rico Fernanda as which was reported by journalist Helbert Chaniago to BBC News Indonesia, Thursday (18/11). Of the five perpetrators who were arrested, the police only named three people as suspects. The three people are DJ, AO and AD. "For the other two perpetrators, we are still coordinating with the Social Services and Bapas. Considering that they are still children under 12 years old," the suspects will be threatened with articles 76 and 82 of the Child Protection Law with a maximum sentence of 15 years in prison. Regarding the threat of castration, we will still coordinate with the prosecutor's office.( Davies Surya, 2022)

Considering the rise in cases of sexual violence, the presence of online media is really needed to disseminate information that educates the public to be more aware and take extra care of children, especially during the child's growth and development period to avoid sexual crimes. LIPUTAN6.COM in reporting cases of sexual violence against children is the media chosen by the author because this media focuses more on this case and the reporting is easy for readers to obtain and digest.

#### Research Methods

This type of research is descriptive qualitative research. The subject of this research is the online media coverage 6.com. This research is qualitative research using descriptive methods. Qualitative research with descriptive methods is research that identifies, clarifies, and analyzes the data that has been obtained. The description is a description of the language as it really is. (A. Yusdianti Tenriawali, 2018: 6)

The data obtained was analyzed using analysis framing William A. Gamson There are two analytical tools framing William A. Gamson (1989) as follows: device (framing Device) and reasoning tools (Reasoning Device). First, the device framing is directly related to the central idea or frame of a news story and consists of the use of certain words, sentences, graphics, images and metaphors. There are several device elements framing (framing device), which consists of: (1) Methapors namely how to transfer the meaning of something by relating it in the form of an analogy, the news text uses different sentences but leads to the same meaning. Metaphor is a linguistic phenomenon that applies at the semantic level. Metaphor is related to the relationship between one word and another to form a meaning. (2) Cathrases is a very interesting phrase in a contract and prominent news, usually in the form of jargon or slogan. (3) Exampler is a sentence that describes or packages certain facts in depth so that they have more weight of meaning on one side to be used as a reference or lesson, linking the news frame or description in the form of a theory or comparison of the news frame. (4) Depicition is a description of facts using words, terms or sentences that have connotative meaning. The connotative meaning itself is a figurative meaning or not an actual word and is related to taste value. The connotative meaning is influenced by the values and norms held by a particular society, which also creates differences in the social

function of words with almost the same meaning. (5) Visual Images in the form of using photos, diagrams, graphics, tables and cartoons to express messages and their use as well as attracting readers' attention so they don't get bored.

Second, reasoning tools (Reasoning Device) namely an idea that does not only consist of sentences, but also has arguments as justification or certain reasons which not only strengthen the opinion and make it acceptable to accept the message which appears to be a natural truth. There are several elements of the reasoning device. (Reasoning Device), which consists of the following: (The charm of Asmaul Husna, 2021: 706). (1) Roots namely causality analysis by prioritizing relationships involving one or more objects which are considered to be the cause of another thing, such as cause and effect. (2) Appeal to Principle namely an attempt to provide justification by claiming a truth by using logic and moral principles to claim a truth when building discourse.

#### Theoretical Study

After conducting a search, the author found several studies related to this research. Representation of Liputan6.Com Online Media in Reporting Sexual Violence against Minors, including:

Muji Rahayu and Herlina Agustin at the Faculty of Communication Sciences, Padjadjaran University in a journal study entitled "Representation of Sexual Violence Against Women on News Sites Delete.id", in 2018. The research results show that Tirto.id packages these news stories to represent sexual violence against women as a common enemy due to patriarchy. This representation is shown by framing the ineffectiveness of law enforcement in Indonesia in handling cases of sexual violence, the negative influence of patriarchy on society and on men who commit sexual violence, as well as the invitation and education for the community to fight together to stop sexual violence against women. (Muji Rahayu and Herlina Agustin, 2018: 115)

Meanwhile, Nur Fajrah Safira, Achmad Herman, and Raisa Alatas, Tadulako University, in the Journal of Social and Political Sciences, with the title "Discourse Analysis of Sexual Violence Against Women in Republika Online News". In 2022. This research contains knowledge about the construction of discourse on sexual violence against women in Republika Online (ROL) reporting. Researchers use the discourse analysis model of Roger Fowler et al., which views language as a particular ideological practice to limit the audience's view of reality by analyzing the dimensions of vocabulary and grammar. This research uses a qualitative approach to collect data by observing and documenting news about sexual violence against women in ROL for the period 23 November 2020 to 10 March 2021. The research results show that Republika Online does not side with women as victims. This is characterized by analyzing the dominant position of women in the news both in terms of naming and describing incidents of sexual violence. (Nur Fajrah Safira, dkk. 2022: 189).

In line with this research, Gufran, Rosmini, Rahmawati Latief, Alauddin Makassar State Islamic University, in a journal, with the title "Media Frame for Reporting Sexual Violence Against Children (Comparative Study of Kompas.com and Detik.com)". in 2021. The research results found that Kompas.com protects victims by not providing more space for perpetrators to defend themselves to the public through the media. This can be seen in the news content, which contains many comments from the police and does not even quote a single statement from the perpetrator. (Gufran, et al. 2021: 161). The difference in this research is that previous research studied sexual violence on Kompas.com and Detik.com and used Robert N. Entman's Framing Analysis theory. Meanwhile, what will be researched is the framing of sexual violence in the online media karet6.com with BCC News.com and using Framing Analysis theory according to William A. Gomson. The similarities are discussing sexual violence and both qualitative descriptive research.

Technological developments which are taking place very rapidly at this time have an impact on the occurrence of a communications technology revolution. This has even happened in various other interconnected areas of life as a result of developments in the world of technology. The development of the internet has created many media online is emerging and increasingly popular among the public. The most popular characteristics of news online is his nature real time, get depth and a wider, even different point of view. Interactivity can also be seen from the provision feed back or feedback from readers who read a news item through the comments column provided. News, stories, events can be published immediately while the incident is taking place. With online media as information, the world feels without boundaries of space and time. (Algu Ready, 2016: 1)

The existence of online media is currently one of the fastest choices for readers to get actual information. As internet technology develops, readers now find it easy to obtain information quickly in a matter of minutes. Now, the flow of information can immediately spread to all corners only through the internet network. Various events and information reach the public through the media online cannot be separated from the role of the media in presenting information and how to interpret an event. One piece of news that reaches the public will have many interpretations and responses depending on the language style (presentation) and method of delivery. This could be embellished with hyperbolic language to attract the interest of news readers and it is also possible that the news presented has been contaminated by the opinion and subjectivity of the news writer. (Faika Burhan, 2017: h. 121-122).

#### Discussion

#### Online media coverage 6.com

Online media is not something foreign to society considering that in the current era of globalization, everyone can easily access all their desired needs through online media. The following is the definition of online media according to experts: Severin and Tankard, revealed that online media is media that is published In cyberspace, the term cyberspace was first introduced by William Gison in his novel, which defines cyberspace as a reality that is globally connected, computer-supported, computer-accessible, multidimensional, anti-visual, or virtual. Halim also thinks about online media, namely websites/sites that function as electronic communication media that are not bound by time and space with the aim of providing actual information that can be accessed by the public directly. in real time. Online media itself is often referred to as New Media. New media are media forms

and media content created and shaped by technological change. The Internet is one new media in the 21st century. As technologies emerge simultaneously, and so-called media convergence. Media convergence is a general definition of a combination of two or more traditional media that become one process and have an impact on other media and their users. The development of mass media means that people can enjoy news from anywhere, including online media.( Rieka Mustika, 2017: 138)

Liputan6.com is an online media that provides a variety of information that readers can get quickly online. In contrast to print media, this site can publish several actual news stories within 24 hours a day. This online media was founded by PT Creative Media Karya on August 24 2000, which is also a subsidiary of Elang Mahkota Teknologi. Liputan6.com presents various interesting topics, starting from political information, business, lifestyle, culinary, to sports news. Liputan6.com not only provides the latest news, but we also choose the right news for you. This site has the slogan, namely Actual, Sharp and Trusted.

Before being published online, Liputan6.com had been around since August 14 2000. Initially this site only presented news broadcast via TV broadcasts on Liputan 6 SCTV. However, since May 24 2012, the shareholder, namely Elang Mahkota Teknologi, decided to create an online site under the banner of PT Creative Media Karya. Furthermore, a major change in news broadcasting occurred in October 2012. Liputan6.com news, which was originally only 30-50 articles a day, increased to hundreds of articles produced. The news channel which was originally only politics, sports and lifestyle, since 2012 has been equipped with business, technology, showbiz, health. Then additional news channels continue to be made every year until they are complete with lifestyle, automotive and regional. Now Liputan6.com is a news site that has influence and is taken into account. Readership continues to increase and is now the largest site in Indonesia.( Faika Burhan, 2017: 128-129)

#### Sexual Violence in Children

According to General Indonesian Dictionary Regarding the meaning of child, etymologically it means a person who is still small or immature. Children are individuals who are in a range of developmental changes starting from infancy to adolescence. Childhood is a period of growth and development starting from infancy (0-1 years), play/oddler age (1-2.5 years), pre-school (2.5-5), school age (5-11 years to adolescence (11-18 years old). The definition of a child according to Law No. 23 of 2002 concerning Child Protection is "a person aged 18 years, including children who are still in the womb". Meanwhile, the definition of a victim according to Arif Gosita is that they suffer physically and spiritually as a result actions of other people which conflict with their own or other people's interests which seek to fulfill their own or other people's interests which conflict with the interests of the sufferer's human rights. Meanwhile, the term sexual violence is an act which can be categorized as unnatural sexual relations and behavior, giving rise to sexual violence Therefore, sexual violence tends to have permanent and long-term psychological and physical impacts. So it can be concluded that a child victim of sexual violence is someone under the age of 18 (eighteen) years, who experiences inappropriate sexual

relations and behavior which results in physical, psychological and financial loss or danger, whether experienced by individuals or groups.( Liany Wulan Asih, 2017: 6-7)

Violence means abuse, torture or ill-treatment, according to WHO: "Violence is the use of physical force and force, threats or actions against oneself, an individual or a group of people or society which results in or is likely to result in bruising/trauma, death, psychological harm, developmental abnormalities or deprivation of rights."

The definition of sexual violence actually does not yet exist or has not been implemented yet Indonesian dictionary According to Achie Sudiarti Luhulima, the definition of sexual violence is a crime related to sex or sexuality and more specifically related to male and female sexuality. How many foreign literature can be found "Sexsual Violence" whose translation is crime or sexual violence is generally defined as criminal acts related to sexuality or marriage that can be committed against men or women. Sexual crimes can include sexual harassment, sexual violence and sexual violations. Children who have experienced sexual abuse in any form generally feel afraid to talk about their experiences. Therefore, every parent must be sensitive and recognize every child's movements that do not appear normal. The following are signs of sexual violence in children that you should pay attention to and be aware of. Sexual harassment does not only come in the form of rape. That may be why many parents are not aware of the signs their children show. Sexual violence can be physical or non-physical violence. (Rieka Mustika, 2017: 140) Here are examples of physical and non-physical sexual violence.

#### 1) Physical abuse

This form of violence is easy to recognize because the consequences can be seen on the bodies of victims of physical abuse cases: the highest percentage is aged 0-5 years (32.3%) and the lowest is aged 13-15 years (16.2%). Violence usually includes hitting, choking, pressing hot objects to the victim's body and so on. The impact of violence like this, apart from causing injury and trauma to the victim, also often causes the victim to die.

#### 2) Verbal Violence

This form of violence is often ignored and considered normal or even treated as a joke. Violence like this usually includes insults, curses, or insults. The impact of violence like this is that children learn to say harsh words, do not respect other people and can also cause children to have low self-esteem.

#### Mental Violence

This form of violence is often invisible, but its impact can be greater than verbal violence. Emotional abuse cases: highest percentage aged 6-12 years (28.8%) and lowest aged 16-18 years (0.9%). Violence like this includes parental neglect of children who need attention, terror, blame, and often comparing things about the child with others, which can cause the child to become mentally weak. The impact of violence like this is that children feel anxious, become quiet, learn to have low self-esteem, and can only be jealous without being able to rise up.

Sexual violence against children according to ECPAT (End Child Prostitution In Asia Tourism) is a relationship or interaction between a child and an older person or a more sensible child or an adult such as a stranger, sibling or parent where the child is used as an object to satisfy the perpetrator's sexual needs. This act is carried out using coercion, threats, bribes, deception or pressure. Activities do not have to involve bodily contact between the perpetrator and the child. (Ghea Alifia Putri, 2015: 10) Forms of sexual violence themselves can mean committing acts of rape or sexual abuse.

## Analysis framing karet6.com in Framing News on Child Sexual Violence

Eriyanto revealed the analysis framing is an analysis used to see how the media constructs reality. Analysis framing It is also used to see how events are understood and framed by the media. Communication perspective, analysis framing used to dissect media methods or ideologies when constructing facts. This analysis looks at strategies for selecting, highlighting and linking facts into the news to make it more meaningful, more interesting, more significant or more memorable, to guide the audience's interpretation according to their perspective. Framing is an approach to find out what perspective or point of view is used by journalists when selecting issues and writing news.

Analysis framing In simple terms it can be described as analysis to find out how reality (events, actors, groups or whatever) is framed by the media. This particular framing of course goes through the construction process. Events are understood in a certain way. As a result, media coverage is on a certain side. All of these elements are not only part of journalistic technique, but indicate how events are interpreted and presented. In analysis framing Currently, the role of the media is seen as part of the wider public discussion. How the media can form certain frames and packages for the audience and how political participants interpret and construct events to be provided to the public. (Kumala Citra Somara Sinaga, 2016: 6) The audience themselves will also process and interpret different things about an issue/event.




Figure 4. 5 Source: Liputan6.com

The news above explains that a Koran teacher and head of a foundation in Bandung City, Herry Wirawan, is facing justice for molesting dozens of his students, some of whom even became pregnant. The trial in this case has been going on since November 11 2021, which resulted in the victim experiencing trauma, there was a victim who gave birth twice and was sentenced to 15 years. Herry Wirawan's bejak behavior was carried out from 2016 to 2021, his actions resulted in the victims' psychological disorders. The victim was taken to hospital to undergo a post-mortem.

## b. Catchphrases

Catchphrases is a very interesting phrase in a contract and prominent news, usually in the form of jargon or slogan, in an article published by Liputan6.com cathrases used are: (Hugyo Symbol, 2022)

From the picture above, it is clear that Herry Wirawan had raped his own students, as explained by Asep, the two witnesses accused the defendant Herry Wirawan of raping dozens of students, some of whom were even pregnant.

#### c. Examplar

Examplar is a sentence that describes or packages certain facts in depth so that they have more weight of meaning on one side to be used as a reference or lesson, linking the news frame or description in the form of a theory or comparison of the news frame. In the article published by Liputan6.com namely; (Yopi Makdori, 2021)

The picture above explains that what makes it strange is that female students should be guided by women too, not men. As Yudi Kurnia explained, non-permanent teachers are rarely found in Islamic boarding schools. From the explanation of Yudi Kurnia as the lawyer for victims of teachers who are rarely in the Islamic boarding school environment, of course this makes things strange.

# d. Depicition

Depicition is a description of facts using words, terms or sentences that have connotative meaning. The connotative meaning itself is a figurative meaning or not an actual word and is related to taste value. The connotative meaning is influenced by the values and norms held by a particular society, which also creates differences in the social function of words with almost the same meaning. 


Figure 4.8 Source: Liputan6.com




Figure 4. 9 Source: Liputan6.com

Consequences or the consequences presented by Liputan6.com in reporting on the sexual violence of 13 female students. (Hugyo Symbol, 2022)




Figure 4. 11 Source: Liputan6.com

The news explains that Herry Wirawan's sexual violence case in terms of the crime of sexual intercourse or rape resulted in more than 1 victim resulting in serious injuries, mental disorders, infectious diseases, disruption or loss of reproductive function. The criminal, Herry Wirawan, was sentenced to death, life imprisonment or a minimum prison sentence of 10 years. As explained by Asep, the punishment deemed appropriate for the defendant and in other articles we also apply additional punishments in the form of concealing one's identity and chemical castration.
